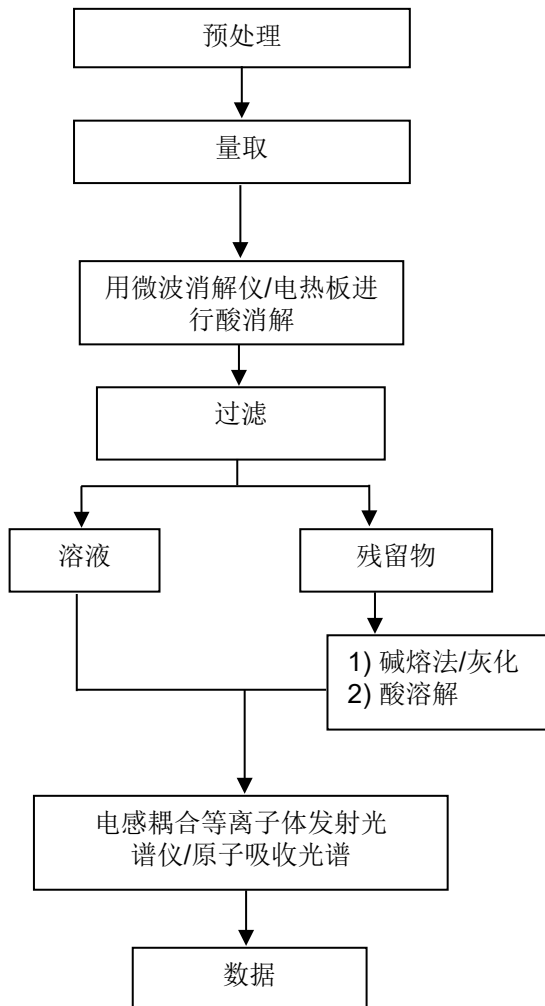

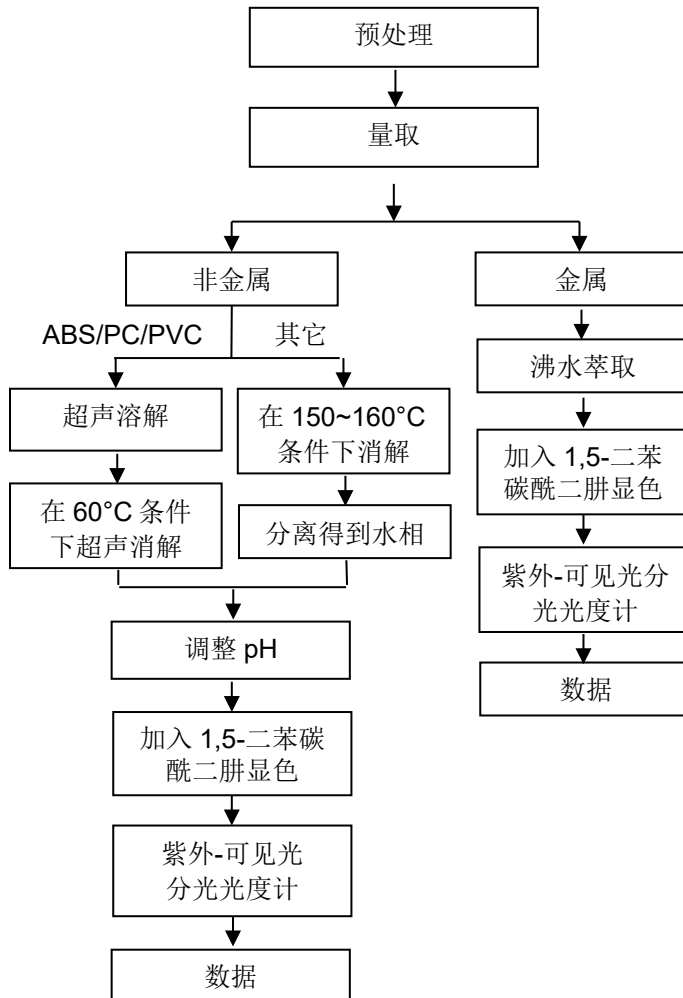

样品按照下述流程被完全消解



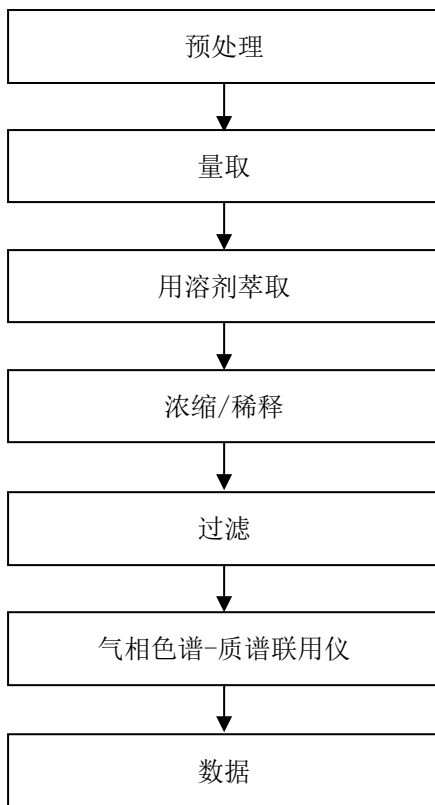
六价铬检测流程图

PBB(s)/PBDE(s)/Phthalates 检测流程图



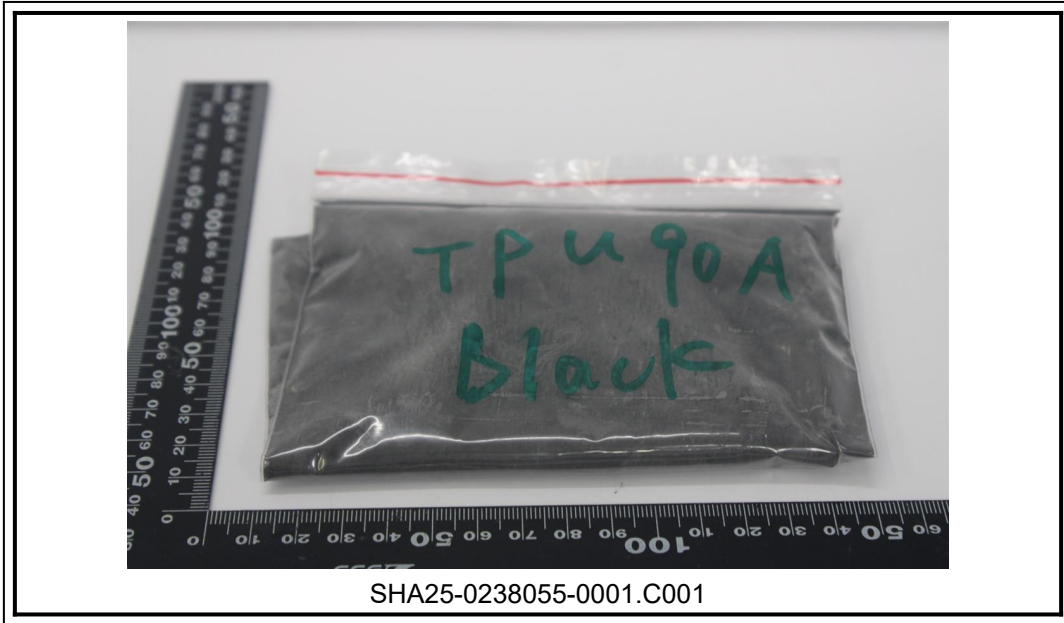
